

orth Island Woodlands Advisory Group (NIWAG) was formed in October 1998 to be a permanent and independent body to provide organized and regular community input to the development, implementation and on-going improvement of Weyerhaeuser's Sustainable Forest Management [SFM] system at North Island Timberlands (formerly MacMillan Bloedel's North Island Woodlands Division).

NIWAG held 8 regular meetings and 2 special event meetings in 2000. A majority of members were present at all regular meetings, and all NIWAG sectors were consistently represented.

## **Achievements & Significant Activities**

Having achieved CSA certification of North Island's operating area in April 1999, a primary NIWAG responsibility is now to monitor and comment on the operation's performance against identified objectives.

In 2000, the most significant of these discussions was the company plan to consolidate dryland sort operations, and the various potential community impacts with that decision. associated Other discussions included maintenance recreational sites and trails, road deactivation. and single-stem harvest trials in sensitive riparian areas.

NIWAG continued its review of performance goals and indicators in the Sustainable Forest Management Plan with no major revisions to those.

## **Education & Field Trips**

On-going member education is an important requirement for effective group functioning of NIWAG. In addition to regular reports from Standing Members and North Island personnel, NIWAG received a number of special presentations designed to increase members' understanding of forest management issues in general and of North Island's operations in particular. These included:
