## **MESSAGE FROM THE CHAIR**

I would like to assure the public that your representatives to MIFLAG, from a broad range of public interests and First Nations, are working diligently to improve a set of indicators to monitor and ensure a sustainable flow of benefits from the MIFO. Your representatives continue to bring forward issues and interests to provide continual improvement to the public participation process and to sustainable forest management.

Through the recent Public Participation Satisfaction Survey, MIFLAG members expressed a general satisfaction with the public participation process. They found it to be inclusive, responsive to membership and adaptive over time. However, some of the MIFLAG members indicated that improvement in communications with the public is required. Providing detailed information in advance of MIFLAG meetings and establishing timeframes for meeting MIFLAG objectives are also areas suggested for improvement. In addition some MIFLAG members reported that MIFLAG needs to collaborate with other local decision makers who are involved with sustainability issues. These concerns will be the focus for improvement to the MIFLAG forest certification efforts in the 2013 year.

Starting in late 2012, trails and recreation sites are one of the new focus areas of the MIFLAG. This issue was introduced by the MIFLAG representatives of Sayward Fish and Game, the Strathcona Regional District Area, and the Village of Sayward. MIFLAG is working to develop a recreation indicator to measure and reflect the recreation interests of the MIFLAG members and the public.

The flow of benefits from the MIFO continued to strengthen in 2012 with stronger markets, increased employment, continued harvesting and planting activities and other forest products. All of these activities provide social and economic benefits to our communities.

MIFLAG has provided public participation to the CSA certification of the DFA since 1998. MIFO continues to express commitment to Forest Certification and to the MIFLAG public participation process. WFP has conveyed this by being responsive to MIFLAG issues, providing technical support, research, meals, meeting space, quest speakers, and supporting our field trips.

Our 2012 Public Outreach events met with mixed success. The outreach with seniors in Campbell River was enjoyable, informative, interactive and well attended. Our public outreach venue at the Campbell River Commons was not as successful and we look forward to a new public outreach at the Pier Street Market on June 23<sup>rd</sup>, 2013.

A big thank you to all of the MIFLAG members who have given their time and energy in working towards sustainable forest management and sustainable communities. I also thank the families of our MIFLAG members who support our efforts and who go without their loved ones while they attend MIFLAG meetings and events.

# MIFLAG 2012 ANNUAL REPORT



Who Are We? Mid Island Forest Lands Advisory Group (MIFLAG) is an independent body providing organized and regular input to the development, implementation, and ongoing improvement of Western Forest Products (WFP) Sustainable Forest Management (SFM) system at the Mid Island Forest Operations (MIFO). The Mid Island Forest Lands Advisory Group operates under Canadian Standards Association Z809-08 (CSA) Forest Certification.

**Our Mission** as volunteer members is to represent the values of our communities, our stakeholder groups, and ourselves in order to ensure Sustainable Forest Management practices on the Defined Forest Area (DFA). This is accomplished by: developing, tracking, discussing and continually improving a set of 'Criteria and Indicators' related to these values; and by having an ongoing dialogue with WFP representatives to ensure that the

environment of the DFA, and the communities which rely on them, are sustained.

**Our Representatives** are from many community stakeholder groups and First Nations from the surrounding communities of Sayward and Campbell River.

**The Defined Forest Area (DFA)** is the land base on which MIFLAG advises WFP and includes approximately 157,000 hectares of provincial crown forest land within Block 2 of Tree Farm License 39. This

includes much of the Memekay River, White River and Adam River watersheds.



Accountability is a strength of the CSA certification found through the process of public stakeholder and First Nation participation through advisory groups like MIFLAG and in auditing, by third party auditors, to ensure compliance with agreed upon measurables, which are called indicators. MIFLAG currently has 43 indicators measuring and tracking a range of items from respect for First Nations values, public education and outreach, to stakeholder and First Nations satisfaction with the process. There are indicators reflecting environmental, social and economic aspects of forest certification. These indicators have been developed by MIFLAG with WFP in our effort to measure continued improvement in Sustainable Forest Management while truly reflecting the community values expressed by MIFLAG representatives.

Certification of WFP - Mid Island Forest Operations (MIFO): Since May 1999, MIFO has successfully passed all audits and MIFLAG continues to express our community and First Nations values through this forest certification process.
